And there were shep-



warned that the criterion of our entry into heaven at the Last Judgment would be our love our care in His name for people who were hungry, thirsty, sick, or in need of any kind, especially people considered the least of our brothers and sisters.

Reflecting on the love of Christ, St. Paul writes that the greatest of all the gifts which God gives us is love. In fact, divine love must motivate our service of neighbor, no matter how much we donate to the needy. "If I give away everything I own...but do not have love, I gain nothing." (1 Cor 13:3)

These are not simply inspiring words; they result in life-changing actions. In his sociological study, The Rise of Christianity, Rodney Stark documents that in the early centuries of the Church pagans were amazed by Christians' care of people. Christians even risked their lives to care for the infirm during devastating plagues, regardless of the sick person's religion. Serving people as the way to please God was unheard of in the ancient Roman world. This intrinsic link between love of God and neighbor has been evidenced during the entire history of the Church, through people like Brother Gerard in

the middle ages, and in our own 21st century Knights and Dames of Malta.

When we defend the Catholic faith, we defend Christ, we defend what He taught, we defend all those He loves and with whom He identified. When we defend the Catholic faith we are upholding Christ's Body, the Church; we keep alive the motivation for ministering to the sick and the poor. That motivation is not just a natural impulse to do something good for another. The motivation is Jesus Christ, His love for us; it is our response to His loving care and compassion for us and all people. "The love of Christ impels us." (2 Cor 5:14)

St. Francis de Sales (Introduction to the Devout <u>Life</u>) taught that lay people bring Christ's love into the real world, whatever their vocation may be. As members of a Lay Order, Knights and Dames draw closer to the Lord each day through prayer, the Sacraments, study of Sacred Scripture, and service of neighbor. A Pilgrimage to Lourdes with the Order of Malta

For many Catholics, "Lourdes water" is a treasured gift, offering the hope of spiritual and physical well-being through intercession of Mary. Lourdes, France, the site where Our Lady appeared eighteen times in 1858 to Bernadette Soubirous, an impoverished, illiterate fourteen-year-old, is among the pre-eminent destinations for Catholic travelers. It has been estimated that approximately 200 million pilgrims and tourists have visited the Sanctuary of Our Lady of Lourdes since 1860, and the shrine now attracts about five million annually. I have been privileged to visit Lourdes several times, most recently as a member of the Order of Malta, whose global associations sponsor an annual, seven-day pilgrimage on behalf of over one thousand "Malades" (French for sick persons).

The "Order" is an worldwide, Roman ancient, Catholic lay religious order dedicated to defending the faith and providing direct service and aid to the sick and the poor. An Introduction to The Order of Malta explains, "The Sovereign Military Order of Malta, known more commonly as The Order of Malta, is an organization with a rich, complex history dating back to the year 1099, and even earlier. It was formed as a hospitaller order and religious order, and later became a military force during the Crusades. For hundreds of years its hospitals were the most advanced in the world. Today it is an international relief agency, and remains a lay religious order of the Roman Catholic Church." As a sovereign entity, it maintains diplomatic relations with over 81 countries, and has status at the United Nations as Permanent Observer. The Order has about 13.000 members and operates in more than 120 countries.

A signature event for the organization is the Lourdes pilgrimage. Every year, in the first week of May (Mary's month), Malta groups from all over the world, comprised of Knights and Dames of Malta, auxiliaries, clergy, medical teams, volunteers, and the Malades and their caregivers, participate in this act of service. Activities include Masses, spiritual talks and reflections, exposition of the Blessed Sacrament, healing baths, anointing of the sick, Stations of the Cross, a beautiful, evening candlelight procession, and camaraderie.

While some Malades are capable of self-care, most are not and are accompanied by their caregivers. These sick and suffering also receive emotional support and service from designated Knights and Dames to whom they're assigned throughout the pilgrimage. It is in these grace-filled relationships that the true spirit of the Order is experienced.

Indeed, the spiritual transcendence of Lourdes was evident both by the inner radiance and joy of the Malades, which shone through despite their ill health, and by the magnanimous spirit of love and charity manifested by those affiliated with this undertaking. One individual who captivated me by this spirit was Kingsley, a young man, wheel-chair bound and paralyzed from the waist down. I engaged him in conversation, curious about his upbeat demeanor, and his visible vigor and strength of He readily and personality. calmly told his story. Three years previously, at a barbeque with friends and family, a guest invited by a friend became violent, resulting in Kingsley's injury from a random gunshot.

Despite this horrible, personal tragedy, Kingsley remained positive, in fact joyful. He has turned his impairment over to God, has been spiritually strengthened since the unfortunate incident, and has forgiven the perpetrator. There was no evidence of bitterness, and he is grateful for his life, having been told by medical personnel that it was a miracle he even survived the shot.

Kingsley's faith is

strong, supported by family, friends, and church. He is persistent in his effort to walk again, and expects to receive a degree in biomedical engineering this year. Kingsley exemplifies the Biblical passage: "...for when I am powerless, it is then that I am strong" (2 Corinthians: 12, 10).

In the eyes of the world, Kingsley may be atypical in his attitude, but this was not the case with the sick at Lourdes. A bishop participating in the pilgrimage told the story of a man with late-stage Following a Mass at cancer. Lourdes, the cancer victim told him that he had been healed. While there had been no physical cure, the man explained to the surprised bishop that he was spiritually healed during the Bishop's homily -- he was no longer afraid to die. A few weeks later he went to the Lord in peace.

The time spent at this sacred shrine should be in the context of a holy pilgrimage, immersed in the healing spirit of the Sanctuary. One becomes rapt, even overwhelmed, by the manifest, deep faith and hope of those seeking the divine intercession of Our Lady. In gratitude and devotion, we should take care to heed Mary's message to Bernadette, to pray and do penance.

During the past one hundred and fifty years, many miracles have taken place at Lourdes, but regardless of whether or not a physical cure occurs, pilgrims leave this holy place spiritually enriched. "In him who is the source of my strength I have strength for everything" (Philippians 4:13).

Our Lady's Inn: Services to Women in Need

The passage in 1973 of Roe V. Wade, legalizing abortion, indirectly led to the opening of Our Lady's Inn. A group of pro-life advocates, having been arrested for picketing outside of a facility where abortions were being performed, sat together in the back of a police paddy wagon in the hot summer of 1980 discussing the plight of so many of the women they had encountered who had come to that facility for an abortion. Many women shared that they were under pressure from family and friends to abort; should they choose not to abort, they would no longer be allowed back into their homes. These faithful men and women began to realize that there was a need for something more than counseling for these pregnant women. They needed a refuge where they could stay until the baby was born. On the ride to the police station the idea was framed for a safe haven for these pregnant women who wanted to choose life for their babies. Over the next two years, pregnant women who found themselves without a home found welcome in the homes of these dedicated pro-lifers.

The dream of the Inn remained constant, and with the cooperation of the Archdiocese of St. Louis, a lease was signed and extensive renovation began on a one hundred year old, abandoned convent in the Soulard neighborhood. With financial support from several Catholic and Christian groups and organizations, volunteers renovated and decorated the home with donated supplies

and materials. Our Lady's Inn opened in January, 1982 offering a life-affirming alternative to abortion, providing shelter and support to address the physical, psychological, and spiritual needs of courageous women.

In 1987 in response to increasing need, a second home opened in north St. Louis
County in a former convent at
St. Catherine Alexandria Parish.
In 1997, both homes were consolidated into a larger facility when Our Lady's Inn purchased and renovated the St. Anthony of Padua Parish Convent in south St. Louis City to lodge up to eighteen pregnant women and their children.

Again responding to the growing demand for its services, Our Lady's Inn opened another home in 2006, this time in Defiance, Missouri in St. Charles County. This home houses up to fifteen women from St. Charles, Franklin, Lincoln, Warren, Washington and surrounding counties.

In addition to the two residential maternity homes, Our Lady's Inn operates a oneyear Transitional Housing Program which consists of four private apartments where a mother and her baby can stay upon leaving the Inn while working towards self-sufficiency and independence. A re-sale shop in the Dutchtown neighborhood, Twice Blessed, was opened in 2009 as a social enterprise, providing job training and experience for women at the Inn.

Upon admittance to the Inn, each woman is supported by a case manager offer-

ing her guidance and structure to assist in her effort to achieve her individual educational, vocational, employment and stable housing goals. Offering classes in nutrition, childbirth, breastfeeding, newborn care and other related topics, staff nurses advocate on behalf of the woman for appropriate prenatal and post-natal care as well as pediatric services for her children. Women share in household chores, learn parenting and life skills, and establish a daily routine. They attend workshops and training programs in stress management, household budgeting, smoking cessation, domestic violence prevention, healthy relationship building, educational and employment readiness.

Since 1982, Our Lady's Inn has served more than 5,200 women. To continue to provide services in its current locations, some capital needs must be addressed. With the continued availability of Missouri State Maternity Home Tax Credits, Our Lady's Inn is in the midst of a Capital Campaign, "Building Blocks for Our Future," with a goal of \$1.5 million dollars to be used for capital improvements, to enhance its financial position, and for expansion to underserved areas of Missouri and surrounding states.

Our Lady's Inn accepts pregnant women and their children with love, and the St. Louis Malta membership is proud to provide its support!
