#### BACKGROUND & HISTORY

This *My Life Story: A Legacy Project* of the American Association of the Order of Malta is based on two programs.

One is the clinical model developed by Dr. Harvey Chochinov's "Dignity Therapy" which is offered to patients who are on palliative care, in hospices and hospitals, the opportunity to talk about their lives and preserve their history.

The second model is from the Eastern Palliative Care, a partnership between Outer East Palliative Care Service, Order of Malta, and St. Vincent's Hospital in Melbourne, Australia offering home-based integrative palliative care. Their volunteer services include "The Biography Project" in addition to respite, companionship, transportation, and homebound support.
